OPENING REMARKS



SRBUHI GALYAN

MINISTER OF JUSTICE OF THE REPUBLIC OF ARMENIA

Srбуhi Galyan is the Minister of Justice of the Republic of Armenia with extensive academic and practical experience in the field of law. She earned her Bachelor's degree from the Faculty of Law of Yerevan State University, and later continued her studies at the same faculty, completing her Master's program and currently pursuing her PhD. She began her professional career in 2014. From 2019 to 2020, Ms. Galyan served as Deputy Minister of Justice, and from 2020 to 2024, she was Deputy Prosecutor General of the Republic of Armenia, overseeing functions related to the confiscation of property of illicit origin, before being appointed as the Minister of Justice of the Republic of Armenia.

Ms. Galyan has been recognized by the US Department of State Bureau of International Narcotics and Law Enforcement Affairs as an Anti-Corruption Champion for her work to establish asset forfeiture as a crucial tool in the fight against corruption. Ms. Galyan is the author of four scholarly articles and co-author of one academic textbook. She also teaches at Yerevan State University and the Justice Academy. Throughout her career, Ms. Galyan has been distinguished by her unwavering commitment to the principles of justice, her high professional standards, and her impartial judgment.
