## OPENING REMARKS



#### **MHER GRIGORYAN**

**Deputy Prime Minister of the Republic of Armenia** 

Mher Grigoryan is the Deputy Prime Minister of the Republic of Armenia and holds higher education degrees in both law and business administration. He initially studied at the Faculty of Law of Lomonosov Moscow State University and later continued and completed his studies at the Faculty of Law of Yerevan State University, earning a qualification as a lawyer. He also completed a six-month qualification course at the Business School of the University of Leeds in the United Kingdom. Mr. Grigoryan began his professional career at the Central Bank of Armenia, where he served as Head of the Legal Department. He then continued his career in senior executive positions in various banks before being appointed as the Deputy Prime Minister of Armenia. Mr. Grigoryan has been repeatedly awarded for his significant contributions to the development of the economy.

#### **SRBUHI GALYAN**

Minister of Justice of the Republic of Armenia



Srbuhi Galyan is the Minister of Justice of the Republic of Armenia with extensive academic and practical experience in the field of law. She earned her Bachelor's degree from the Faculty of Law of Yerevan State University, and later continued her studies at the same faculty, completing both her Master's and PhD programs. She began her professional career in 2014.

From 2019 to 2020, Ms. Galyan served as Deputy Minister of Justice, and from 2020 to 2024, she was Deputy Prosecutor General of the Republic of Armenia, overseeing functions related to the confiscation of property of illicit origin, before being appointed as the Minister of Justice of the Republic of Armenia.

Ms. Galyan is the author of four scholarly articles and co-author of one academic textbook. She teaches at Yerevan State University and the Justice Academy. Throughout her career, Ms. Galyan has been distinguished by her unwavering commitment to the principles of justice, her high professional standards, and her impartial judgment.

DR. JOHANNES KOEPP

Department Chair - International Disputes (Firmwide), Partner, Baker Botts

Dr. Johannes Koepp is the co-head of Baker Botts International Disputes Group. He has been recognized by Chambers UK, The Legal 500, Euromoney, The International Who's Who of Commercial Arbitration and Global Arbitration Review as one of the leading specialists in the field.

His practice focuses on international arbitration, both commercial and investor-state. He has represented clients before most major arbitral institutions, as well as in ad hoc proceedings. Dr. Koepp also serves as arbitrator, both as sole and party-appointed arbitrator, and is included on the roster of several major arbitral institutions. He speaks English, German, French and Spanish fluently.

He is a member of the American Arbitration Association—International center for Dispute Resolution's International Advisory Committee, Publications Committee and Advisory Committee on Brazil; a former Vice President (for U.S.) of the London Court of Arbitration's North American Users' Council, and a member of the Singapore International Arbitration center's User's Council, the International Arbitration Club of New York, the Arbitration Committee of the International Institute for Conflict Prevention and Resolution, the New York City Bar Association's Committee on International Commercial Disputes, Club Español del Arbitraje, and the Panel of Recognized International Market Experts in Finance (P.R.I.M.E.) Arbitration Rules Drafting Committee, and a founding board member of the New York International Arbitration Center.

Grant Hanessian is editor of ICDR Awards and Commentaries Vol. I and II (Juris Pub.), co-editor of International Arbitration Checklists (Juris Pub.), Gulf War Claims Reporter (ILI/Kluwer), and former editor of Baker McKenzie's International Litigation & Arbitration Newsletter, and Baker McKenzie's International Arbitration Yearbook. Mr. Hanessian is annually recommended by international arbitration reference guides, including Chambers Global and USA Guides, The International Who's Who of Commercial Arbitration ("superb counsel and arbitrator"), and Expert Guide to Leading Practitioners in International Arbitration (ranked among "Best of the Best" in international commercial arbitration).
